
OFFICE MEMORANDUM

Subject: Constitution of Committee to review Contributory
 Health Services Scheme (CHSS) Rules,

The CHSS Review Committee was constituted vide DAE OM dated 14/11/2012 to review CHSS Rules to improve the working of the scheme and to review the per-capita expenditure entailed by it. The Secretary, DAE had advised for a detailed study in respect of some issues which were recommended by the said Committee. With a view to take a decision in respect of such issues and to consider few more items brought to the notice of the Department, it has been decided to constitute the CHSS Review Committee consisting the following officers :

1. Joint Secretary (A&A), DAE	Chairman
2. Director(IR&W), DAE	Member
3. Representative of Director, BARC	Member
4. Representative of Director, IGCAR	Member
5. Representative of Director, RRCAT	Member
6. Representative of CE, NFC	Member
7. Representative of CMD, NPCIL	Member
8. Representative of CE, HWB	Member
9. IFA, BARC	Member
10. Head, Medical Division, BARC	Member
11. Chief Medical Officer, DAE-Kalpakkam Hospital	Member
12. Chief Medical Officer, NFC, Hyderabad	Member
13. AO-III, BARC Hospital	Member Secretary

2. The terms of reference of CHSS Review Committee will be as follows :
- (i) Annual medical examination for Group 'A' officers of Central Civil Services of age 40 years and above.
 - (ii) Introduction of CHSS at Nagpur, Jaipur, Shillong, Jamshedpur, Bhubaneswar and Allahabad.
 - (iii) Revision of rate for artificial dentures.
 - (iv) Re-classification of entitlement of hospital accommodation under CHSS in respect of retired employees.
 - (v) Enhancement of reimbursement under Liberalised Emergency Scheme (LES).
 - (vi) Reimbursement in the cases of Mediclaim Policy Holders.
 - (vii) Ceiling on costly treatments.
 - (viii) Reimbursement for OPD treatment to retired employees who stay outside CHSS area.
 - (ix) Concluding rate contracts for procurement of generic drugs centrally
 - (x) Revision of method of calculation of CHSS contribution from retirees paying on yearly basis.
 - (xi) Centralisation of CHSS facilities.
 - (xii) Extension of CHSS facilities to dependent unmarried daughter beyond the age of 25 years.
 - (xiii) Extension of CHSS to deputationists after retirement.
 - (xiv) Other issues (if any) requiring attention of Department in CHSS matters.
3. The Committee may submit its report within 6 months from the date of its constitution.
