1.13 <u>General Provident Fund:</u> Subscription to the GPF shall be stopped during the last 3 months before superannuation. On retirement, the accumulation in GPF along with interest as per Rule 11 of GPF Rules is paid.

Only the component of Employee's Contribution with accrued Interest will be paid. The contribution from the Government will be retained and will not be payable to the employee.
